



## 2. Starten Easy IP-Cam

De Easy IP-Cam heeft een ingebouwde wifi-chip die direct met uw draadloze thuisnetwerk kan communiceren. Daarom dient u voor het eerste gebruik van de Easy IP-Cam uw wifi-netwerk in te stellen, en een netwerk kiezen waarmee de camera het internet kan benaderen via de AP (Access Point) mode.

### Installeren Easy IP-Cam

Plaats een Micro-SD kaart in de Micro-SD kaartsleuf, max. 32 GB. Steek de stekker van de camera in een stopcontact, de Easy IP-Cam schakelt zich in. Stel de camera op de juiste hoek in.

#### Opmerking:

1. De Easy IP-Cam heeft geen ingebouwde batterij. Als u de camera uit het stopcontact haalt wordt deze uitgeschakeld en is dan offline.
2. Alle instellingen zijn echter in de camera opgeslagen, zelfs als deze wordt uitgeschakeld. Als de stroomvoorziening weer wordt hersteld gaat de camera aan, en wordt automatisch met de wifi verbonden.

### Benaderen AP Mode

Indien de Easy IP-Cam nog nooit gebruikt is, dan komt hij direct in AP mode terecht.

Om te beginnen gaat de rode status LED ongeveer 8 seconden branden. Hierna knippert hij meer dan 20 seconden lang, en activeert de wifi-functie.

De gereed LED knippert snel groen als de camera in AP mode komt.

**Opmerking:** Druk op de reset toets om de standaardinstellingen van de camera in AP mode te herstellen.

## 3. Configureren Easy IP-Cam

### Installeren Technaxx Easy IP app

Zoek de Technaxx Easy IP app op in de Apple Store voor iOS, en de Google Playstore voor Android. Installeer deze op uw mobiele apparaat. Tik op het Easy IP-icoon om te starten.



### Camera Toevoegen (+)

Druk op het Camera Toevoegen icoon  om een camera toe te voegen. Zoek de UID QR-code op de camerabehuizing op. Gebruik de QR-code lezer om de UID van de camera te lezen.

Voer het UID Wachtwoord "888888" en naam (aanpasbaar) van de camera in. Voer het wachtwoord van de wifi-verbinding in waarmee de camera met internet kan verbinden en druk op .

#### Voor iOS:

1. Druk op de **Home** en selecteer Instellingen, ga naar **WIFI** netwerk en kies "**CamAP**" en u hoeft hiervoor geen wachtwoord in te geven.
2. Wacht ongeveer 60 sec. en wacht tot u  ziet verschijnen.



3. Druk opnieuw op de **Home** knop en ga terug naar de **Easy IP** app.

De camera herstart binnen 60 sec. en vervolgens gaat de groene LED continue branden.

Wijzig het apparaat wachtwoord en druk dan op .

Easy IP verbind met de camera en is klaar voor het monitoren vanaf uw smartphone als de camera online is. Druk a.u.b. op de "OK" toets als u een bericht ziet tijdens het maken van een verbinding!

#### Opmerking:

1. Er kunnen maximaal 16 camera's worden toegevoegd in de app.
2. Als het wifi netwerk is veranderd, zet dan de camera terug in AP mode, en stel het nieuw netwerk vervolgens in.
3. **Zorg ervoor dat de wifi-verbinding voldoende bandbreedte heeft omdat het anders erg lang duurt voor de camera toegang tot het internet krijgt.**

### Eenvoudige Mode Camera Toevoegen

Zolang de Easy IP-Cam een wifi-netwerk verbinding heeft via AP-mode, kunt u eenvoudige mode gebruiken om deze camera aan andere mobiele apparaten toe te voegen, en via de Easy IP app te monitoren.

Druk op het Camera Toevoegen icoon  om een camera toe te voegen. Zoek de UID QR-code op de camerabehuizing op. Gebruik de QR-code lezer om de UID van de camera te lezen.

Voer het Camera Wachtwoord in en druk op .





## 4. Gebeurtenis opnemen


De Easy-IP Camera heeft een ingebouwde PIR-sensor (Passieve Infrarood Sensor) die infraroodsignalen kan detecteren die uitgestraald worden door bewegende objecten zoals mensen of dieren. De standaardinstelling voor de intervaltijd om de PIR-sensor te activeren is 30 seconden. De PIR-sensor wordt alleen na het einde van de intervaltijd geactiveerd. Deze intervaltijd voorkomt dat meerdere foto's van hetzelfde object of dier worden genomen, en begint opnieuw te tellen als de video-opname beëindigd is.

**Voorbeeld:** De opnametijd is 60 seconden en de PIR-uitsteltijd is 30 seconden, deze kunnen niet gewijzigd worden.




## Monitoren Gebeurtenisdetectie

De camera neemt automatisch een videoclip op zodra de PIR-sensor een bewegend object heeft gedetecteerd. En een bericht wordt naar uw mobiele apparaat gestuurd waarop de Easy IP app draait.



Dit bericht blijft zichtbaar op uw mobiele apparaat totdat u de gebeurtenis heeft bekeken.






